Little Sugar Farm

A Century of Hospitality Rooted in the Ozarks

Nestled in the quiet beauty of Jane, Missouri, Little Sugar Farm is more than just a place to stay—it's a piece of living history. Established in 1914, this family farm has seen over a century of change while remaining under the care of the same family for five generations. Today, it's a one-of-a-kind destination where rustic charm meets modern comfort, inviting visitors to reconnect with the land and each other.

The story of Little Sugar Farm begins with early settlers who made their home along the banks of Little Sugar Creek. Over the years, the land was lovingly worked by hand, serving as a traditional farmstead for much of the 20th century. In 2006, current owners' sisters Jana and Niki—descendants of the original homesteaders— inherited their grandparent's (Clark and June) farm and decided in 2010 to create one of the first vacation rentals in the area by renovating the 2,800 square foot farmhouse.

During the COVID lockdown Jana and her

husband Paul began to reimagine what the farm could become. Drawing inspiration from the growing interest in outdoor travel and "glamping," they transformed the property into a welcoming retreat for guests from all over the country. Today, Little Sugar Farm is best known for its unique blend of eco-luxury and natural simplicity. The farm offers a variety of accommediati

Today, Little Sugar Farm is best known for its unique blend of eco-luxury and natural simplicity. The farm offers a variety of accommodations, including a renovated farmhouse that sleeps up to eleven guests, as well as seven well-appointed canvas tents—four safari tents and three bell tents—each set on raised wooden platforms. These tents come with queen or twin beds, organic mattresses, fresh linens, and even electricity, lighting, and

Nominating committee to meet in August

New-Mac Electric Cooperative's annual meeting set for October 25

The 2025 nominating committee, in accordance with New-Mac's current bylaws, will meet at the New-Mac Electric Cooperative office on Highway 86, Wednesday, August 13, 2025, at 10 a.m.

Their task, at this meeting, is to nominate individuals to serve on the New-Mac Board of Directors. This year, directors will be elected from Districts 2, 7 and 8 at the upcoming annual meeting on Saturday, October 25, 2025.

Article III, Section 3, of the New-Mac Electric bylaws sets the date for the nominating committee meeting not less than sixty (60) days before the date of the annual meeting. This section of the bylaws states:

Members of the nominating committee for each year shall appoint the nominating committee for the following year consisting of nine (9) members of the Cooperative, one person from

each of the districts of the Cooperative. It shall be the duty of said committee to prepare and post in the principal office of the Cooperative at least sixty days before the next annual meeting a list of nominations for Directors. Said list to contain at least two candidates for each Director for each vacancy occurring. In the event that any member of said nominating committee so chosen shall die, cease to be a member of the Cooperative, or for any reason become un-able to serve on said committee, then the Committee shall appoint a person from the same district to take his/her place with full power to act as a member of said committee. No member of the Board of Directors nor candidate for the Board of Directors may serve on such committee. No member of the nominating committee may nomi-

nate himself/herself as a Director candidate.

Any fifteen or more members may make other nominations in writing over their signatures within fifteen days from the date of posting of the nominations of the nominating committee as above set out; and such nominations shall be delivered to the principal office of the Cooperative which shall cause it to be posted at the same place where the list of nominations made by the

along Highway 71 to the North line of Section 18, Township 23, Range 32, thence East long section lines to the Southeast corner of Section 12, Township 23, Range 32, thence North to place of beginning.

District No. 8 – Commencing at the Northwest corner of Section 33, Township 23, Range 34, thence East to the Northeast corner of Section 34, Township 23, Range 34, thence South to
